Such action by the Voting Members shall be taken at a Meeting of the Voting Members next following such action by the Executive Board. Notice of such action by the Executive Board and the substance of such change shall be given to all Voting Members no later than the time for giving notice of the Meeting at which the Voting Members may act.

**Effective Date:** This revised edition of the Constitution shall take effect at the close of the Annual Meeting held on August , 2005.
